THE PROPOSED EXPANSION OF HEATHROW AIRPORT

HEATHROW'S PUBLIC CONSULTATION: 17 January – 28 March 2018

In October 2016, the government announced that a new north west runway at Heathrow is its preferred scheme for the expansion of airport capacity in the South East.

Since then Heathrow has been developing proposals for how the expanded airport might look, how it might operate, and how we might best reduce the potential effects, including proposals for compensation and noise insulation.

Our consultation represents a major milestone to deliver Heathrow expansion in a way that is fair to our local communities, meets strict environmental tests and connects all of the UK to global growth.

We want to hear your views on our emerging proposals through Heathrow's public consultation which is being run between 17 January and 28 March 2018.

What is being consulted on?

There are two parts to our consultation.

- The first relates to the physical changes on the ground needed to build a new north west runway and operate an expanded airport.
- The second relates to potential principles we could apply when designing the new airspace required for an expanded airport. At this early stage, we are not consulting on future flight path options.

Heathrow consultation



Background

When the government announced its support for a new runway at Heathrow, it sent a clear signal to the world that Britain is open for business.

Heathrow expansion is an opportunity to ensure the country and the next generation have the infrastructure they need long into the future.

It will create thousands of training and employment opportunities locally, and build a long-term, sustainable legacy.

We want to create a world leading airport that allows for more flights, increases the number of destinations we fly to and improves passenger experience while reducing effects on local communities and surrounding areas.

Why have I received this leaflet?

This consultation is conducted by Heathrow and you have received this leaflet because we want you to have your say on how we build a future airport. This is your chance to help us shape our plans to deliver an expanded Heathrow.

There will be two parts to this first consultation:



AIRPORT EXPANSION CONSULTATION

As well as the new runway and terminal infrastructure, we need to use nearby land for construction and make changes to the local road network, the M25 and local rivers.

We have identified options for how we could deliver an expanded Heathrow, and set out potential approaches to managing and reducing the effects of expansion on local communities and the environment.

We are seeking views on these options and our emerging proposals at this early stage, and welcome all feedback to help shape our plans.

We expect to run a second consultation next year prior to submitting our application for planning consent.



AIRSPACE PRINCIPLES CONSULTATION

An important part of expanding Heathrow will be the changes that have to be made to airspace and flight paths to accommodate the new runway.

This is subject to a separate Airspace Change Process and will require Heathrow to undertake three stages of consultation.

Before designing possible future flight paths, we need to build a set of principles or 'rules' that will form the basis for them. We are seeking views on these principles in this consultation.

We will run a second consultation, which we expect will take place next year, to establish what local factors should be taken into account when developing new flight paths.
